Vice President's Message

Hello everyone,

Plans for the 2013 INAIR Annual Conference are well underway. As I mentioned in the last newsletter, the conference will be March 7 and 8 at the Indianapolis Marriott North. From the proposals we received I can tell that this will be a very enlightening and informative conference.

The official conference flier was distributed earlier over the INAIR listserv. In it, you'll find a brief description of our four pre-conference sessions. We have sessions on project management, new ICHE resources, collecting and reporting IPEDS data, and using Veera software by Rapid Insight. We hope that you'll be able to take advantage of one of these exciting learning opportunities.

I am also pleased to announce that once again this year, The Association for Institutional Research (AIR), and INAIR are co-hosting a one-day IPEDS Workshop for data providers and users in conjunction with INAIR's Annual Conference. Funding is provided by the National Center for Education Statistics (NCES). These sessions will include six hours of instruction taught by experienced practitioners from across the country. We have two modules to be taught this year on March 5, the day before the conference:

- O IPEDS Data and Benchmarking: Supporting Decision Making and Institutional Effectiveness-Module 1 is designed for participants with little to no experience in the area of conducting benchmarking studies or with the IPEDS Data Center. This module introduces the fundamentals of creating benchmarks to measure institutional effectiveness. The module provides an overview of the types of comparison groups that can be constructed using IPEDS data, with examples of appropriate use. Participants will use actual data from the IPEDS Surveys, including the IPEDS Data Feedback Report and Executive Peer Tool. Exercises and resources will demonstrate processes to establish key performance indicators and identify variables to refine comparison groups.
- O IPEDS Data and Benchmarking: Supporting Decision Making and Institutional Effectiveness-Module 2 is designed for participants familiar with the concepts of benchmarking and building comparison groups, the IPEDS surveys, and the IPEDS Data Center. This module focuses on practical applications for using IPEDS data in an institutional effectiveness (accreditation) selfstudy. Participants will use IPEDS survey data to create a benchmarking study, discuss specific research questions, and identify the types of comparison groups and key performance indicators that could address each. Exercises will focus on using the IPEDS Data Center to extract and analyze data.

The sessions will be provided at no charge to participants and include workshop materials, breaks, and lunch. Participants may apply for up \$500 in travel assistance awards through AIR, which might be a great way for offices with limited funds to travel to INAIR. Registration began on January 9, and the registration link can be found on INAIR's conference webpage. Please send an e-mail to ipedsworkshops@airweb.org for more information.
